

RULES OF THE DEMOCRATIC PARTY OF BERNALILLO COUNTY

AMENDED JANUARY 2, 2026

PREAMBLE

In accordance with The Democratic Party of the State of New Mexico Preamble, the Democratic Party of Bernalillo County hereby adopts the most recent version of the State Rules as its primary governing document. The following rules are supplemental to the adopted State Rules and are numbered to agree with the numbering system in the parent document.

In accordance with Article I, Section 3 of the DPNM Rules these supplemental rules may be adopted at a County Convention or at a County Central Committee meeting for which “Adoption of County Party Rules” is on the agenda and announced in the call.

The membership of the DPBC Election Committee will be 5-7 voting members appointed by the DPBC Chair. Its members shall include:

- Person with expertise in Event Planning
- Person with experience in County Elections
- Person with expertise in Web Management

The committee may add other non-voting, ad hoc, members as needed.

The Election Committee will be the Election Administration Team for all County elections. It will have the authority to plan, execute and review all elections performed by the County. Among other activities, it will set the schedule and timelines for elections, create the ballot, notify and register eligible party voters, explain ballot and voting procedures, tabulate and announce results.

Section 4 – County Officers

4.1 – Election of County Officers

The County Chairperson shall call a meeting of the County Central Committee pursuant to the call issued by the State Chairperson for the selection of county officers and State Central Committee members. Publication of notice shall be according to Article I, Section 3, Rule 3.4.5 of the DPNM Rules. Officers in order of rank are: (a) Chairperson, (b) a First Vice-Chairperson of the sex opposite that of the Chairperson, (c) a Second Vice-Chairperson of the sex the same as that of the Chairperson, (d) Secretary and (e) Treasurer. The County Central Committee shall elect the Chairperson and Vice-Chairpersons. The Chairperson shall appoint a Secretary and Treasurer. None of the officers need be members of the County Central Committee prior to being selected. The officers shall serve for two years or until their successors are elected or appointed. All voting for officers shall be conducted by non-secret ballot according to Article I, Section 5, Rule 5.5.2.1 of the DPNM Rules.

The County Conventions shall certify delegates and alternates elected at the ward level to be delegates and alternates to State Conventions, including Pre-Primary Election Nominating Conventions and Post-Primary Election Conventions, adopt resolutions, adopt or amend the rules of the County Party organization, and conduct other business pertaining to the county as provided for in the call. State Central Committee members are automatic delegates to the County and State Pre-Primary Conventions as provided for in Article II, Section 5 of the DPNM Rules and do not reduce their Ward's allocation of delegates. Ward Chairs who are NOT State Central Committee members are automatic delegates to the County and State Pre-Primary Conventions but DO count against their Ward's delegate allocation.
