October 8: Voter registration closes by mail or online. www.berncoclerk.gov/elections

October 8: Absentee ballots can be mailed to voters.

October 19: Early Voting & Same Day Registration at expanded locations. Most 10am-7pm

October 22: Deadline for absentee ballot request to be received.

November 2: Last day of early voting, Sat 10am to 7pm.

November 5: Election Day, open 7am to 7pm
